Please note: Tourist tax Greece

According to the current decision of the Greek government, a tourist tax will be levied for stays in Greece from January 1st, 2018.

This tax is charged by the hoteliers upon arrival or departure of the guests.

The amount of the tourist tax depends on the official country category of the accommodation, not on the classification of the tour operator.

For 1 and 2 star accommodation the tax per room/night is 0.50 euros (approx. 0.55 CHF).

For 3-star accommodation, the tax per room/night is 1.50 euros (approx. 1.65 CHF).

For 4-star accommodation, the tax is 3 euros per room/night (approx. 3.30 CHF).

For 5-star accommodation, the tax is 4 euros per room/night (approx. 4.40 CHF).

Double room (DB2):

- Double, main building, shower or bath, hairdryer, air conditioning, safe (extra charge), TV (satellite), telephone, refrigerator, balcony

Economy double room (DE1):

- Double, main building, shower or bath, hairdryer, air conditioning, safe (extra charge), TV (satellite), telephone, refrigerator

Family room (FB1):

- Families, main building, bunk bed, shower or bathtub, hair dryer, air conditioning, safe (for a fee), TV (satellite TV), telephone, refrigerator, balcony

Double room sea view (D5M):

- Double, main building, sea view, shower or bath, hairdryer, air conditioning, safe (extra charge), TV (satellite), telephone, refrigerator, balcony
